CRR student Sumithra M., who is a hostelite in St. Alphonsa Girls Hostel had been noted to be on long absence since September 28th (Saturday) 2024 wherein she had taken out pass and leave to proceed to her native place with signed permission from concerned authorities (Hostel Warden etc.). However, it has been noted after 54 days' absence that she had not reported back to the college nor had she been at home as per her parents' complaint.

She has reported back to college on 19.11.2024 evening with her parents with reasons stated as to her absence being attributed to her personal assistance extended to her friend Mrs. Gracy of Anadhan Nagar, Tim Garden, Nagercoil (Ph. No. 6385716822) who was hospitalized and reportedly debilitated. She apologized for not informing her parents' and for her Unauthorized Long Absence and has promised not to repeat the same. She has agreed in the Principal's chamber in presence of her parents i) that she shall not leave the campus without explicit consent from her parents or without they themselves taking her out ii) She shall continue with her studies without any further break iii) She shall prepare wholeheartedly and sincerely NEET entrance exam of 2025.

Principal has told her that she will have to suffer and extension posting equivalent to the days of her absence (54 Days) which may mean that her posting may extend from January (the scheduled month of completion of CRR of her batch) to sometime in March. She has agreed to in presence of her parents.

It is a evident from the current enquiry there is no contact between the mentor Dr. Bevin Shaga and his mentee Ms. Sumitha M in this current year or in previous years.

Furthermore, it is come to light that the hostel and its wardens have no monitoring of their wards presence or welfare.

It is also noted with grave and glaring evidence that e-governance attendance monitoring system is not alerted to mentors, coordinators, Vice-Principal or to Principal.
