MEMORANDUM OF UNDERSTANDING
BETWEEN

(Unit of Rajas Medical Institutions)

This Memorandum of Understanding (MoU) is entered into by and between KALASALINGAM ACADEMY OF RESEARCH & EDUCATION (KARE) and RAJAS DENTAL COLLEGE & HOSPITAL (RDC&H)

Wherein both partner institutions agree on co-operation in research collaborations and student and faculty exchange that would be mutually beneficial towards common goals and drive towards academic excellence. The area of co-operation is focused towards identifying common areas of research and innovations. Such interaction may include cooperation in a variety of joint academic and educational activities such as:

- Joint research projects and publications, including work by the undergraduate, postgraduate, doctoral, and post-doctoral students at the partner institutions
- Faculty and Student exchange
- Joint conferences and workshops
- Visit by faculty, professional staff and students

Co-operation in Education and Research

Objectives:

1. To appoint an expert team headed by the Nodal officers of response to coordinate and ease the process of joint development of curriculum and research objectives.
2. To interact and identify common areas of research leading to development of joint multicentre projects which can be conducted and published together.
3. To conduct on-site needs assessment, identify strategically suitable faculty who will take the programme forward as Research Supervisors / Programme mentors.
4. To execute viable financial planning to secure funds, fix course agenda & fee structure and develop time bound plans for project implementation.

The primary contacts for this MoU are Prof. Dr. Johnson Raja James, Vice Principal (Admin) & Director of International Affairs for Rajas Dental College & Hospital (RDC&H) and Prof. K. Sundar, Dean-School of Bio and Chemical Engineering and Director of International Research Center for Kalasalingam Academy of Research & Education. Both the parties may enter into specific written agreements whenever appropriate to clarify and define the nature, extent and terms of operation for the proposed collaborations, including intellectual property ownership and funding issues.

Both institutions will make available their facilities, the use of facilities and resources by the other party will be at free of cost if there is a joint collaborative activity, otherwise the users will pay a nominal fee.




For agreed upon activities, both this MoU will be valid for five (5) years unless terminated by one of the parties. Either institution may withdraw from this MoU provided, a written notification of the withdrawal is given to the other institution atleast three (3) months prior to the desired withdrawal date. This MoU may be renewed for another period for five (5) years upon mutual written consent of the two institutions before the date of expiration. This MoU will take effect on the date the signatures of the institute officials are affixed to this document.
